This means that the emission factors used represent the average annual carbon intensity of the power grid in the country the processes take place in.</p>

Exclusions

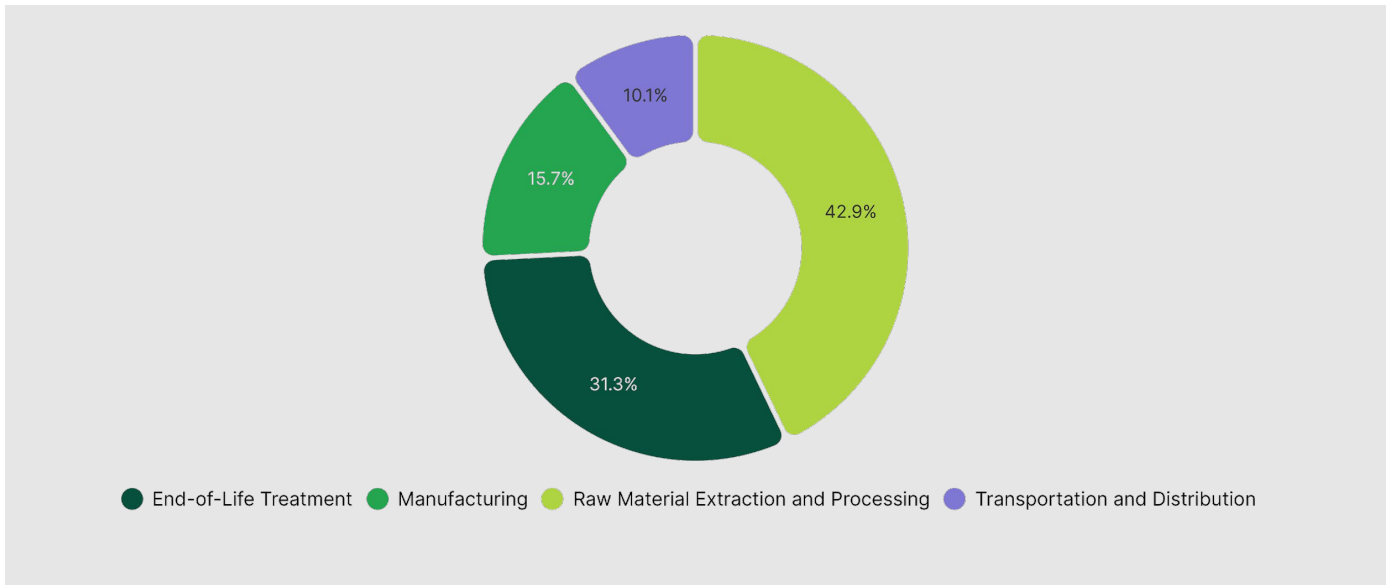
The impact of secondary packaging and writing utensils are excluded from this assessment.
