Exclusions


The impact of secondary packaging and writing utensils are excluded from this assessment.



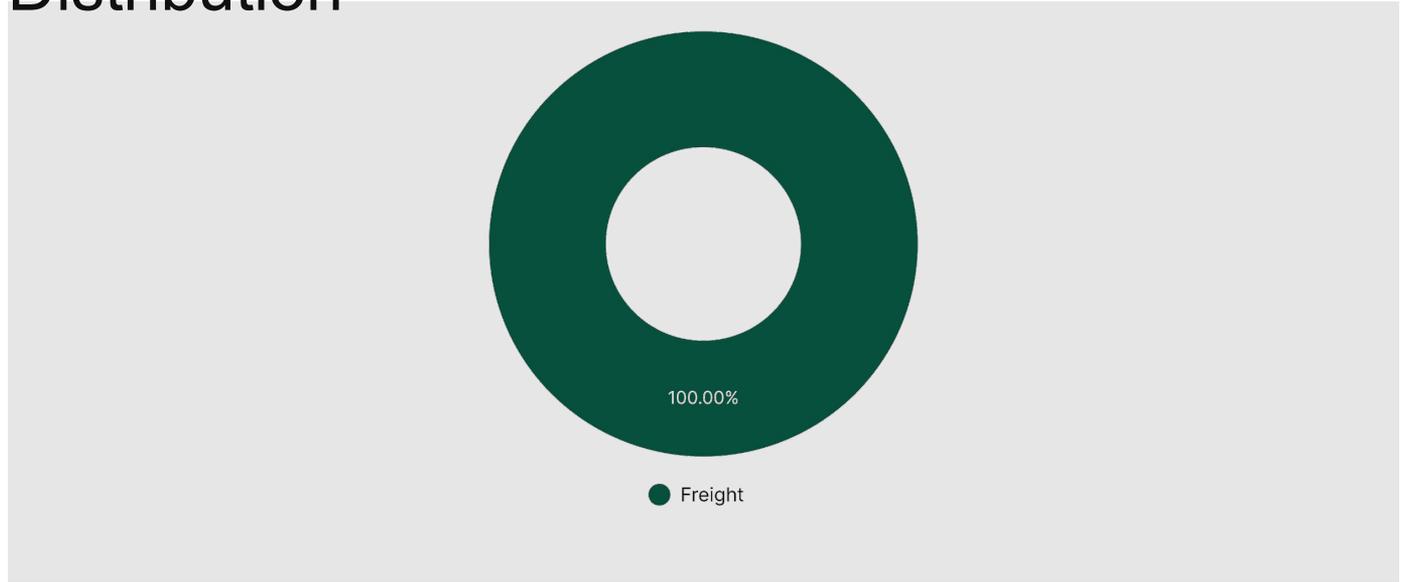


Climate Change - Transportation and Distribution
