# Gum, Mark & Graffiti Remover



# **Product Description**

Gum, Mark & Graffiti Remover utilises a powerful, safe, ecofriendly, non-flammable organic solvent to remove chewing gum, adhesives, tyre and other black marks, graffiti such as ink, permanent marker/spray paint and nail varnish from a variety of surfaces

## How does it work?

By softening, lifting and holding the soil away from the surface, Gum, Mark & Graffiti Remover prevents further spreading action so soils can be quickly and easily wiped, scraped or rinsed away allowing for effective and complete removal.

### **Directions for use**

The product requires a period of contact with the soil, after which marks/deposits can be easily wiped/scraped away. Brush or clean the surface and spray neat product over the affected area. Allow the recommended contact time and rub surface with a hard brush, cloth or scraper to remove any gum, marks or graffiti. Wipe the surface dry with a cloth. Repeat as necessary. Test on a small non-critical area first. Always use as supplied.

#### **Gum Removal**

Spray neat product over the affected area. For non vinyl floors such as tiles, concrete etc allow 3 minute contact time. Gently scrape the underside of the gum deposits with a plastic or metal scraper to lift residues from the surface. For vinyl floors allow 30 seconds contact time and use as above.

#### **Mark Removal**

Firstly apply BioHygiene All Surfaces & Floor Cleaner to clean and remove any surface debris. Work on a small area at a time. Spray neat product sparingly over the affected area. For non vinyl floor such as tiles or concrete allow a minimum contact time of at least 3 minutes, wipe the area with a cloth or pad to remove the stain or go over the affected surface with a scrubber drier to complete the cleaning process and remove all black marks. For vinyl floors, allow 30 seconds contact time and use as above.

#### **Graffiti Removal**

Coverage rates for graffiti removal vary significantly depending on factors such as: age, type and thickness of the graffiti, temperature, moisture, porosity, substrate and equipment used. For heavy duty graffiti removal a repeat application may be necessary to completely remove all traces of graffiti. Spray neat product liberally over the affected area. Allow a minimum contact time of at least 3 minutes and gently scrub the surface. Rinse as necessary or wipe clean.
