# Environmental Impact Assessment

<b>Functional unit</b>	<p>The functional unit is a quantified performance of a product system for use as a reference unit. ## Exclusions


The impact of secondary packaging impact and writing utensils are excluded from this assessment.



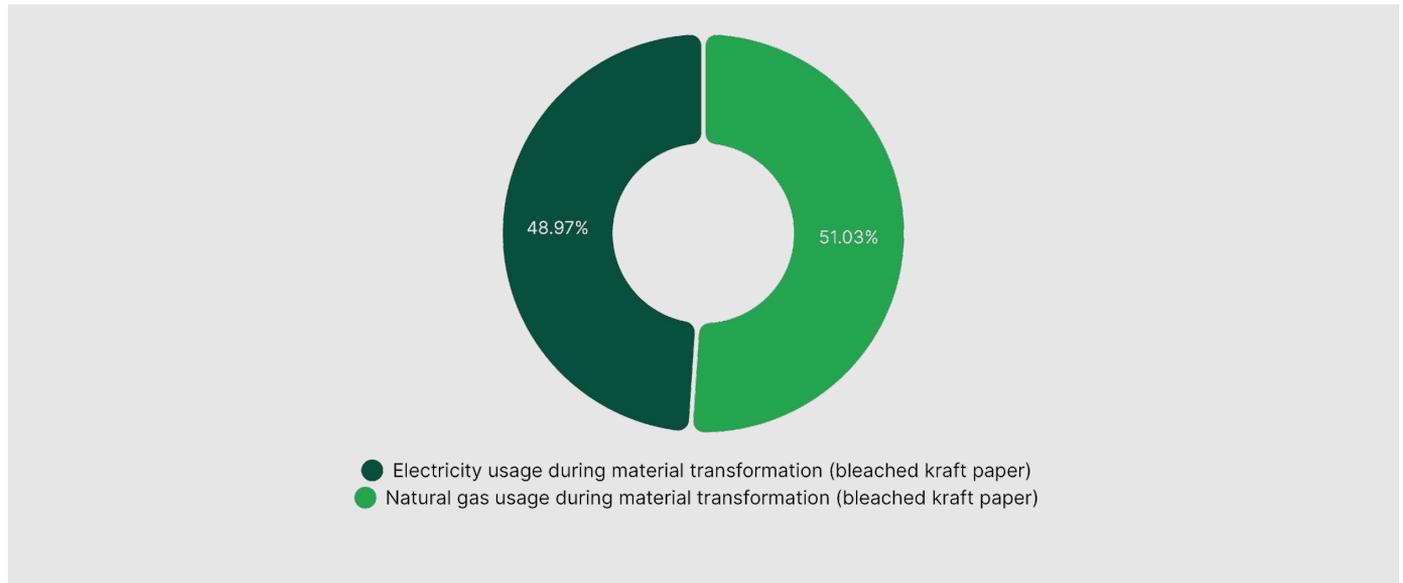

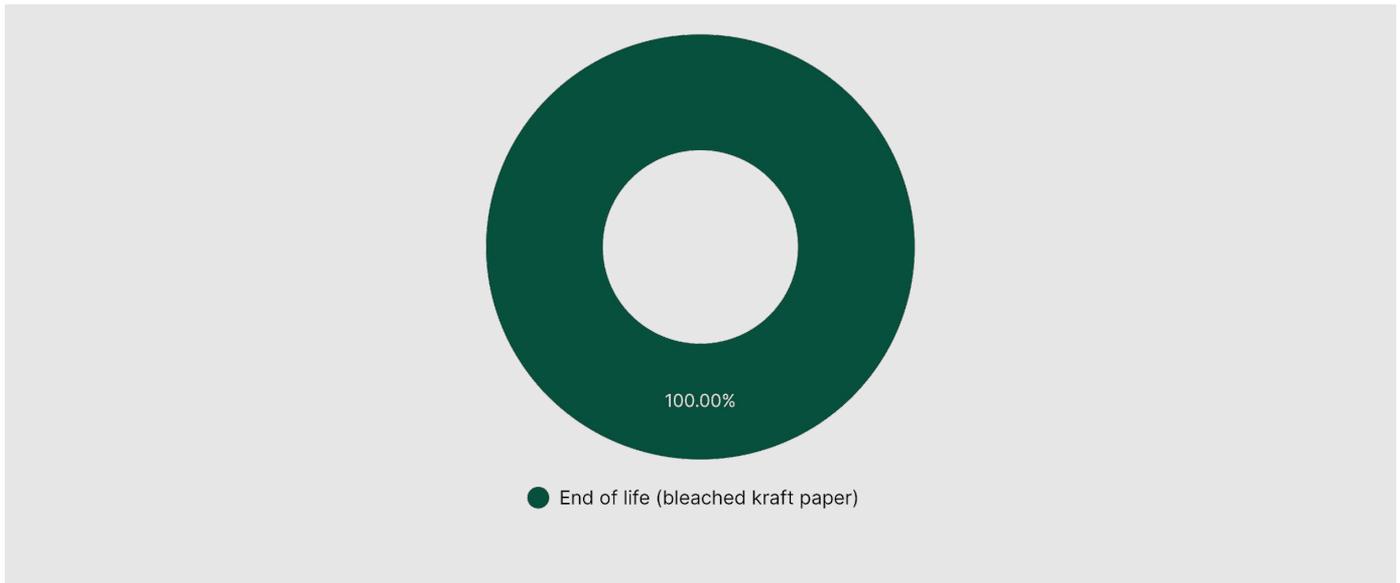
