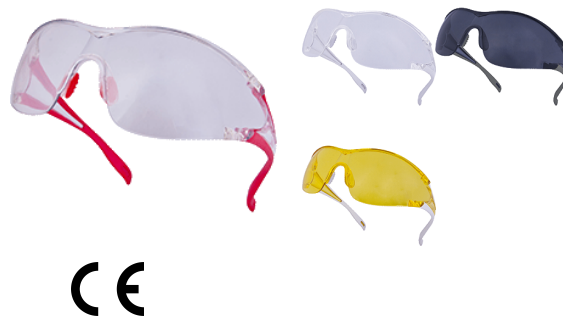

**Description :**

Ergonomic glasses. Polycarbonate lens. Sports look. Twin material arms. Extra comfort soft PVC nose piece.

Colourless lens version (UV400, anti-mist, anti-scratch), reference: EGONGRIN. Comply with EN166 & EN170 standards.

Yellow version (UV400, anti-mist, anti-scratch), reference : EGONBCJA . Comply with EN166 & EN170 standards.

Smoke lens version (UV400, anti-mist, anti-scratch), reference : EGONGRFU . Comply with EN 166 & EN172 (solar protection) standards.

Colourless flash version (UV400, anti-scratch), reference : EGONROLM, Comply with EN166 & EN170 standards.

**Materials:**

Frame and lens : polycarbonate

Weight : 26 g

**Strong points:**

Extra comfort soft PVC nose piece.

Lateral protection.

Extra soft arms.

**Instructions for use:**

These goggles protect against low energy shocks of particles thrown at high speed 45m/s and for high temperature ( $55\pm 2^{\circ}\text{C}$  et  $-5\pm 2^{\circ}\text{C}$ )\*. Before every use, it is recommended to check the goggles carefully, and change them if damaged. Before entering a risky area, make certain that the goggles are comfortably and firmly adjusted on head.

**Limits to use:**

Not to be used for protection against further hazards than defined above. The goggles, when in contact with the skin may cause allergic reactions to susceptible individuals. If this occurs leave the hazard area, remove the spectacles and seek medical advice.

**Instructions for storage:**

Store in the packaging provided out of direct sunlight, away from chemical and abrasive substances

**Instructions for cleaning / maintenance:**

Clean under tepid water and soap, rinse and wipe with a soft, dry, antiplush and non abrasive cloth. If necessary, disinfect with a neutral or medical detergent. Do not use solvents. When unused, do not leave the goggles out of their package, or do not put them near other items such as tools or other metallic objects if they are not protected.

**Performances :**

Comply with requirements of the European Directive 89/686, special for ergonomics, harmless, comfort, airing and flexibility and with the requirements of the European standards EN166:2001 (FT\* - Optical Class 1) and - EN170:2002 (Ultraviolet filters)
