

Clean under tepid water and soap, rinse and wipe with a soft, dry, antiplush and non abrasive cloth. If necessary, disinfect with a neutral or medical detergent. Do not use solvents. When unused, do not leave the goggles out of their package, or do not put them near other items such as tools or other metallic objects if they are not protected.
