# Environmental Impact Assessment

<b>Functional unit</b>	<p>The functional unit is a quantified performance of a product system for use as a reference unit. One of the primary purposes of a functional unit is to provide a reference to which the input and output data are normalized (in a mathematical sense). The functional unit of this analysis is "500 page(s) of A4 paper for writing".</p>
<b>Impact Indicator</b>	<p>The impact is measured through the "IPCC 2013 GWP 100a" method.</p>

## Exclusions

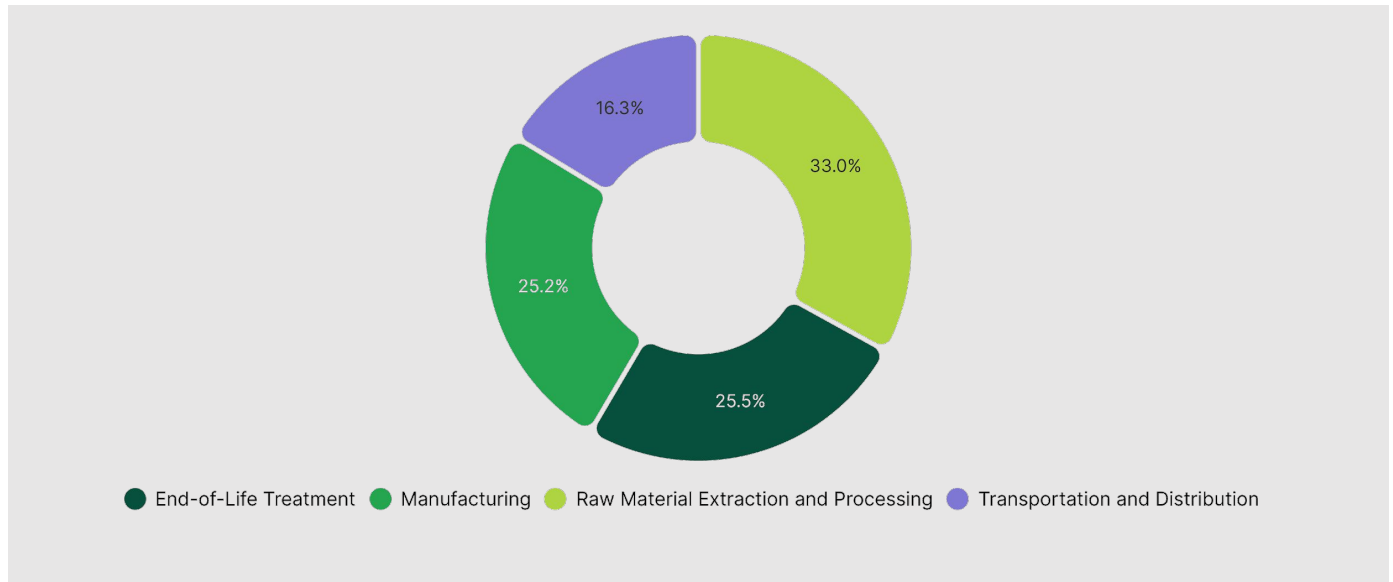
The impact of secondary packaging impact and writing utensils are excluded from this assessment.

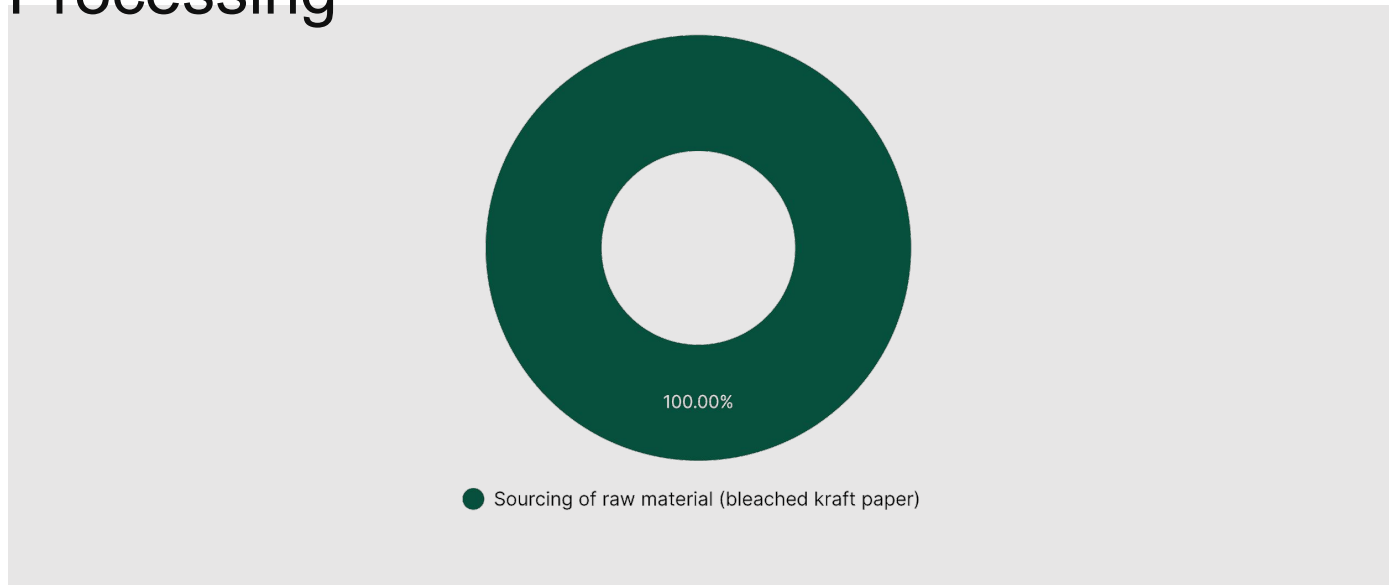

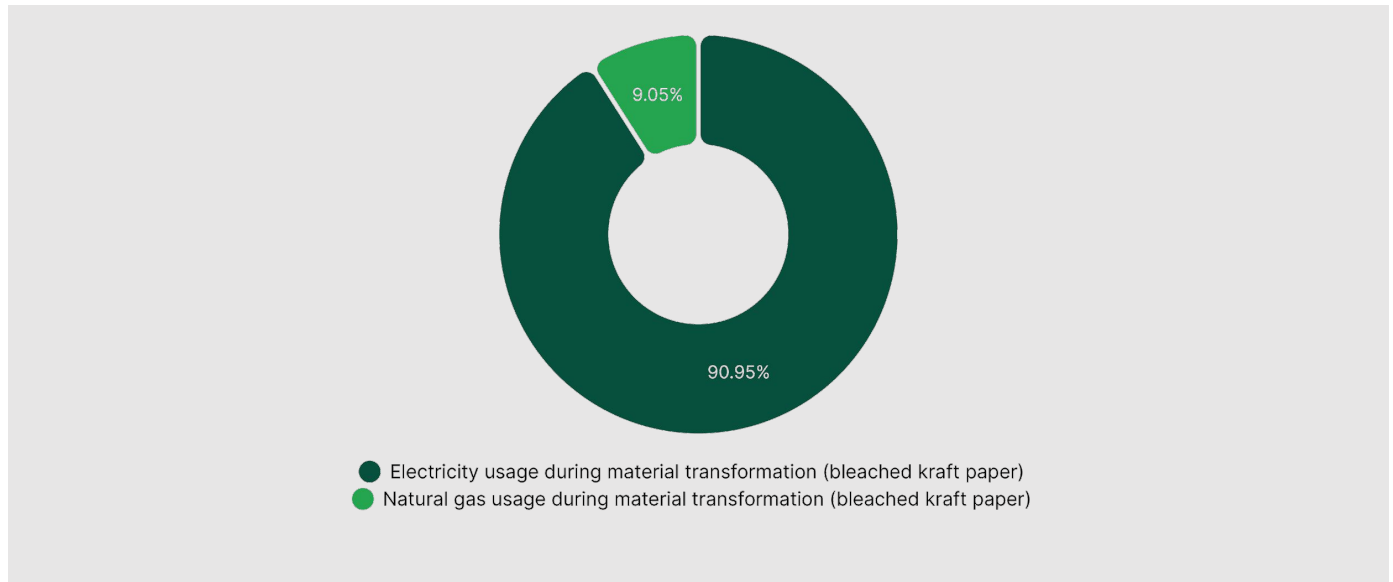
