Exclusions

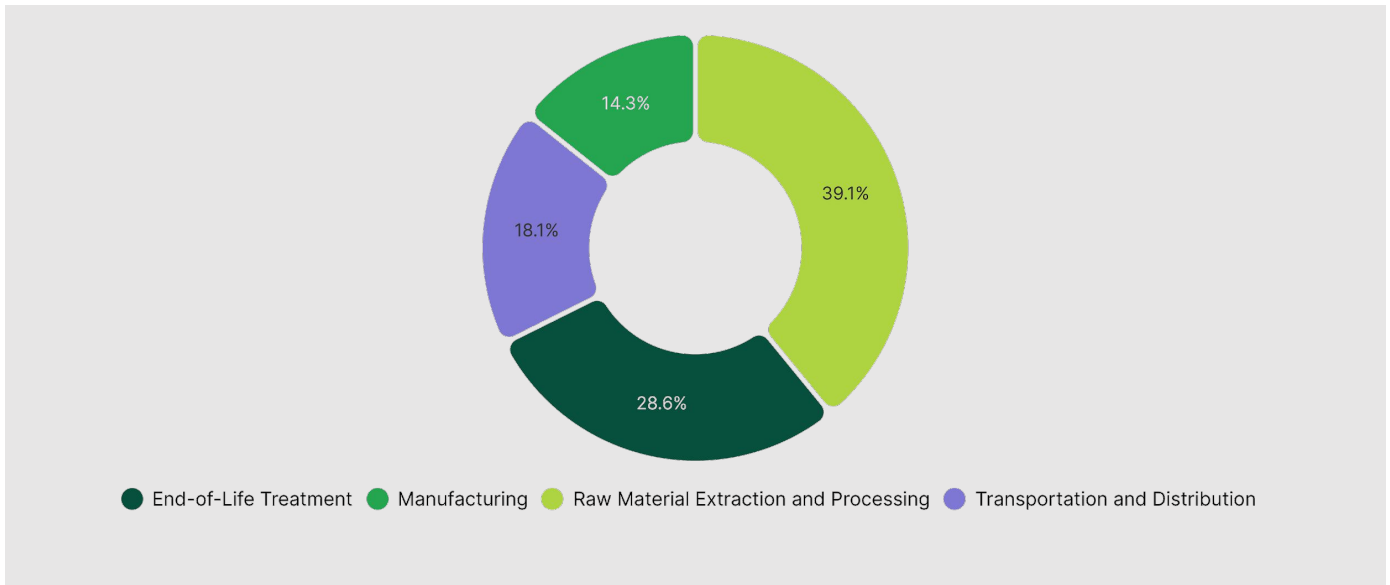
The impact of secondary packaging and writing utensils are excluded from this assessment.
