<p>Functional unit</p>	<p>The functional unit is a quantified performance of a product system for use as a reference unit. <p>Electricity impact calculation method</p>	<p>Following guidelines from the GHG Protocol, the impact of electricity is calculated using the location-based approach. This means that the emission factors used represent the average annual carbon intensity of the power grid in the country the processes take place in.</p>

Exclusions

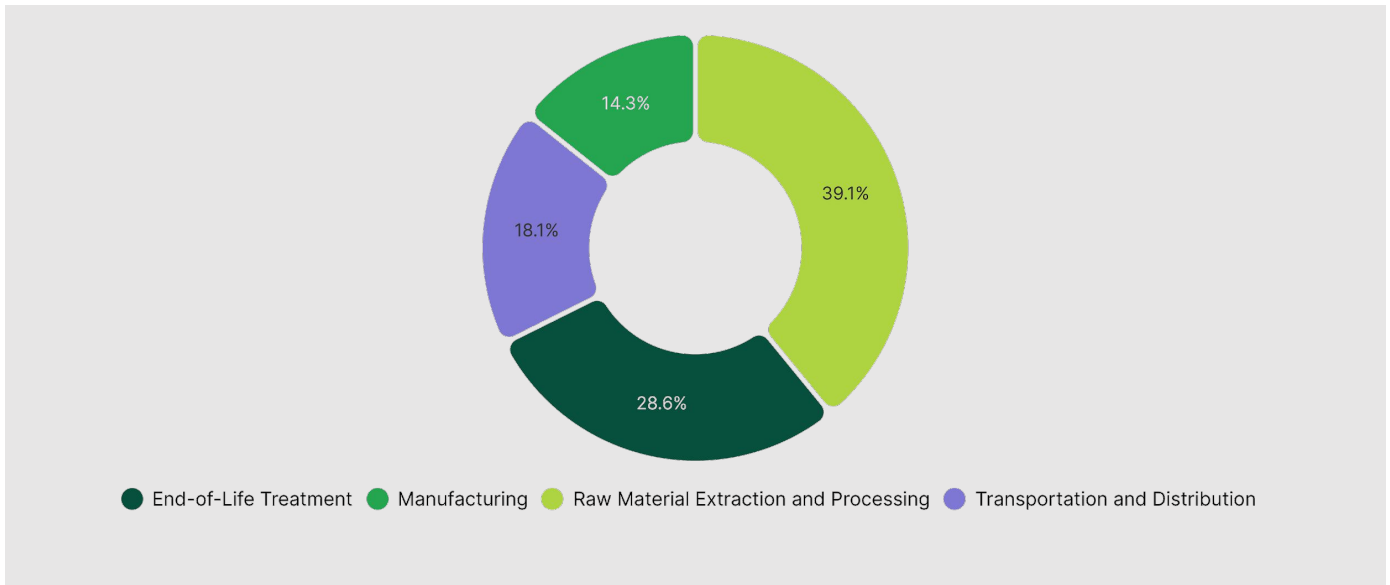
The impact of secondary packaging and writing utensils are excluded from this assessment.
