<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

<b>Ingestion</b>	Rinse mouth thoroughly with water. Remove any dentures. Give a few small glasses of water or milk to drink. Stop if the affected person feels sick as vomiting may be dangerous. Do not induce vomiting unless under the direction of medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. ### Advice on general occupational hygiene

#### Appropriate engineering controls

Provide adequate ventilation.
