Product Assessment:

The respiratory protection assessment of the product range was based on BS EN 136:1998, the English language version of EN 136:1998 Respiratory protective devices - full face masks, both documents incorporating Corrigendum Number 1.

Product description:

Each model/size of mask is constructed of a silicone face seal, with a polycarbonate lens and straps which comes in three shades of grey silicone depending on the size and the Full Face Mask has a four-strap head harness assembly.

The products are also sold in various kits and packaged variants and a spectacle kit is available for use with the 3M 6000 Full Face Mask.

The three Masks are of the same design only differing in terms of the size of the body of the Mask. The Masks are designed for use with a pair of the same type of 3M Filters and, where applicable, their associated 3M Filter Platforms and 3M Filter Retainers from the range specified in the Reference Leaflet for the Masks.

The Masks are also Certified to EN 14594 as a component of the 3M S-200+ system.

The 3M Filters and the 3M S-200+ system are the subject of separate CE Certificates.

The 3M 6000 Series Full Face Masks meet limited clauses of EN 166:2001 Personal Eye Protection including 7.1.4.2.2 Increased Robustness - Complete Eye-Protectors , 7.2.2 Protection against High-Speed particles (Medium Energy Impact) and 7.2.8 Lateral Protection.

Some models are sold into the Automotive Aftercare Division market and are identical in product construction to the standard industrial market model shown. The only difference is in product identification.
